




NPR Commentator INA JAFFE

Stained Glass Window Dedication



The Association of Retired Faculty stained-glass window in the Heritage Museum commemorates FSU's current and retired faculty, staff, and administrators.

The Association of Retired Faculty at Florida State University presented a stained-glass window commemorating the dedication of the institution's current and retired faculty, staff and administrators during a ceremony June 6. The window, which is installed in the university's Heritage Museum in Dodd Hall, depicts figures representing a diversity of academic disciplines, gender, race and age.



The idea for the window came from the late Fred Standley, a retired English professor who served as president of the Association of Retired Faculty in 2007-2008.

"Fred was known as a champion of faculty governance, for advancing women and minorities and for his generous treatment of all people," said Carol Darling, the Association's Past President and a retired professor of family and child sciences.

Standley chaired the association's original committee that was tasked with developing the idea into a reality by working with artists from the university's Master Craftsman Studio. That committee consisted of Max Carraway, Marie Cowart, Tonya Harris, Michael Launer, Anne Rowe and Nancy Turner.

"He retired at age 70 and said he was going to miss teaching but was going to be so happy to give up committee work. And what's the first thing he did? Joined the Association of Retired Faculty," Jayne Standley said.

"After Fred's death a year and a half ago, we carried on with the original committee's vision of a window that represented our organization in its acknowledgement of faculty, staff and administrators," said Carol Darling, the Association's Past President.

Darling thanked the Master Craftsman Studio artisans who created the window: Juan Comas, Karen Pritzl and Sarah Coakley, the studio's public relations director and glass artist. She also thanked the members of the association who contributed money to pay for the window.

During the ceremony, Rowe, a retired English professor and former dean of the faculties, read the window's inscription plaque: "Gift of the Association of Retired Faculty: A tribute envisioned by and, in large part, brought to fruition by Professor Fred L. Standley."



"We discussed many times that Florida State is a unique and wonderful educational opportunity for our young people, and it's the people of FSU that are so committed to ensuring that each one has a quality educational experience," she said.

The association's window is one of 35 stained-glass windows that commemorate various people, clubs and milestones from the institution's history.

Each window was designed and created by the Master Craftsman Studio, a unique auxiliary of the university's Facilities Department. The studio serves numerous campus departments, creating a wide range of artistic objects that beautify the Florida State campus. FSU students who work for the studio have opportunities to hone their artistic crafts while learning the business of running a professional art studio.

Administrative Up-date

Vice President for Faculty Development and Advancement



Dr. Janet Kistner was appointed Vice President for Faculty Development and Advancement on April 8, 2016 after serving as interim since January 2015. She

also served as Associate Vice President for Academic Affairs since October 2012. Her major administrative responsibilities as Associate Vice President involved interdisciplinary hiring initiatives, development of academic programs and activities to enhance students' career readiness, and preparation of the university's annual accountability and work plan reports.

Dean of the College of Business



Dr. Michael D. Hartline became the sixth dean of the College of Business on April 1, 2016. As dean, he is committed to improving academic programs, enhancing the student experience, and moving the college into the Top 25. In addition to playing a major role in securing a \$100 million gift from Jan Moran and the Jim Moran Foundation, he worked with development staff to raise roughly \$54 million for the college and led the college's new building campaign.

Before assuming his current position of dean, he served as interim dean for nine months. Prior to that position, he was associate dean for Strategic Initiatives and the Charles A. Bruning Professor of Business Administration.

Dr. Gibson is the founding dean of Northeastern University's College of Science. While at Northeastern, in collaboration with Faculty and staff, he was instrumental in helping the College raise \$26 million in philanthropic funds over five years. Gibson also worked with faculty to raise annual research funding by 50 percent and during his tenure the University moved up 25 points in national rankings.

Prior to his role as founding dean, he served as a professor in one of the nation's top 10 engineering schools, the University of Illinois at Urbana-Champaign.

Dean of the College of Law



Erin O'Hara O'Connor, JD, has been named the Dean of the College of Law after a national search. She joined Florida State University on July 1, 2016.

Dean O'Connor comes to Florida State University from Vanderbilt University where she served as the Milton R. Underwood Chair in Law and director of graduate studies for the Ph.D. Program in Law and Economics at Van-Dr. J. Murray Gibson was named Dean of the derbilt's law school. At Vanderbilt, Dean O'Connor also FAMU-FSU College of Engineering on July 1, 2016 served as the FedEx Professor of Law (2010-2011), asby FAMU Provost Marcella David and FSU Provost sociate dean for academic affairs (2008 TO 2010), and director of the Law and Human Behavior Program (2007-2010).

> She has held positions at Northwestern University School of Law, Georgetown University Law Center, George Mason University School of Law, Clemson University and University of Chicago Law School.

He received a BA in philosophy and social sciences from Florida State University, where he served as the student body president and a university trustee. A Truman and Rhodes Scholar, he has a master's degree in comparative social policy and a Ph.D. in education from the University of Oxford.

Assistant Provost



Mr. Paul Harlacher was named Assistant Provost on December 4, 2015 in the Office of the Provost.

Paul has worked with Florida State University for 15 years in the Division of Finance and Administration, and most recently as the Associate Director for the University Business Administrators, which supported various academic units.

Survey: Providing Critical Data on Emeriti Value

The latest report of UC emeriti activity from all UC campuses again proves to be an effective tool in documenting the continuing value of emeriti to their campus, the UC system and the state of California.

The Council of University of California Emeriti Associations (CUCEA), an organization composed of representatives from the Emeriti Associations of its older nine UC campuses has, as one of its primary goals, fostering supportive relations not only among its member associations, but also among all levels of the University's governance to benefit the teaching, research and service missions of the University of California.

As well, 537 UC emeriti reported that they had been selected for an honor, award or other recognition, with 197 receiving honors in the category of "lifetime achievement;" and 42 were awarded the status of Fellow by their colleagues in academic and professional societies. Many in the creative arts had taken part in musical performances, most on multiple occasions, while others were involved in theater arts or completed fiction, poetry, or biographical projects. Within the Health Sciences, 52% of respondents indicated that they had maintained their licenses to practice and 29% were still doing clinical work. Perhaps of even greater importance is the fact that more than 700 participants had been involved as mentors to UC students.

These findings are compelling. All of their accomplishments act as independent validations of the claims the UC makes about the excellence of its faculty. They illustrate that for hundreds of UC emeriti, in spite of formal retirement, their work and dedication to scholarship, their campus and productivity continues. Perhaps the most remarkable finding is that hundreds of UC emeriti remain engaged in their research and writing even 15-20 years after retirement.


AROHE would like to suggest that obtaining and documenting the accomplishments of their emeriti and retirees should help all colleges and universities to understand the importance of continuing the engagement, services and support of this population.


